

OFFICIAL RULES – FABRICLAND WESTERN CANADA REGION’S 49th BIRTHDAY PRIZE GIVEAWAY

1. Eligibility: This Campaign is open only to those who enter at <https://woobox.com/go7j6m> and who are age of majority as of the date of entry. The Campaign is only open to legal residents of British Columbia (BC), Alberta (AB), Saskatchewan (SK) & Manitoba (MB), and is void where prohibited by law. Employees of Fabricland its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, provincial, and local laws and regulations. Void where prohibited.
2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Fabricland as final and binding as it relates to the content of this Campaign.
3. Campaign Period: Entries will be accepted online starting on March 2, 2026, 8:00am EST and ending April 2, 2026, 11:59pm EST. All online entries must be received by April 2, 2026, 11:59pm EST.
4. How to Enter: The Campaign must be entered by submitting an entry using the online form provided at <https://woobox.com/go7j6m>. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Fabricland. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Fabricland.

Prizes: At each of the 30 participating Fabricland locations, including the participating independent franchise locations, there are three (3) Gift Certificates to be won, valued at 1 x \$349.00 CAD, 1 x \$249.00 CAD & 1 x \$149.00 CAD. To be won in each Western Canada province (BC, AB, SK & AB) there is one (1) Janome 5300QDC-G Sewing Machine, valued at \$1,749.00 CAD, and one (1) Sewing Basket of Notions Goodies, valued at \$374.09. The specifics of the prize shall be solely determined by Fabricland. No cash or other prize substitution shall be permitted except at Fabricland's discretion. The prize is nontransferable. listed in the "Select an eligible location for prize pickup" dropdown menu on the Giveaway entry form. Legal residents of these cities can enter the Giveaway, but will need to pickup any prize winnings at a participating location from the list.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner selection will be chosen at random through Woobox. Winners will be notified by email within seven (7) days following the selection of Winners. Fabricland shall have no liability for Winners' failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winners cannot be contacted, are ineligible, or fail to claim (either by picking up or arrange a specific date for pick up) the prize within 10 days from the time of award notification, the prize will be forfeited and an alternate Winner will be selected from the same group of entries, per province or region, depending on the prize. Prize must be picked up from the participating Fabricland store selected by the Contestant in the "Select an eligible location for prize pickup" dropdown menu in the Giveaway entry form. Winner must provide government issued photo ID when collecting the prize from the corresponding Fabricland location. Receipt by Winners of the prize(s) offered in this Campaign is conditioned upon compliance with any and all federal, provincial and local laws and regulations. Fabricland reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions.
