## Official Rules - National Sewing Month Giveaway - September 2024

- 1. Eligibility: This Campaign is open only to those who enter online at <a href="https://woobox.com/f6yax2">https://woobox.com/f6yax2</a> between September 1, 2024, 8:00am EST and September 30, 2024, 11:59pm EST. The Campaign is only open to legal residents of British Columbia (BC), Alberta (AB), Saskatchewan (SK), Manitoba (MB) and Ontario (ON) that are 18 years or older.
