

**OFFICIAL RULES – FABRICLAND ONTARIO REGION 1
57th BIRTHDAY IN-STORE GIVEAWAY, APRIL 2025**

Giveaway is open to Ontario (Canada) residents only, 18 years of age or older, excluding employees of FABRICLAND DISTRIBUTORS INC. and their immediate families. Only one entry per person/per week will be allowed; duplicates will be removed.

This in-store giveaway is a weekly draw taking place four (4) times over the month of April 2025. The period for depositing ballots shall be during business hours from April 1-7, April 8-14, April 15-21, and April 22-28.

A total of 25 x \$25 gift certificates will be available each week per participating Ontario Region 1 store location. A total of 100 gift certificates will be available per location during the month of April.

At the end of business on April 7, April 14, April 21 & April 28, ballots from the box will be collected and 25 random Winners will be selected each week.

All in-store Winners will be notified by phone and/or email by the store location where their names are drawn. Instructions regarding the claiming of prizes will be given at the time of notification of winning. All prizes have no cash value and must be accepted as awarded. Valid identification must be presented to claim prizes. All Birthday Giveaway Winners will be posted online.

**OFFICIAL RULES – FABRICLAND ONTARIO REGION 1
57th BIRTHDAY ONLINE GIVEAWAY, APRIL 2025**

The Campaign is only open to legal residents of Ontario (ON), and is void where prohibited by law. Employees of Fabricland its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, provincial, and local laws and regulations. Void where prohibited.

The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Fabricland. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules.
